The Company has suffered losses during the year and the total equity stands at Rs. 242.69 as at 30 September 2020 as
against Rs. 295.43 as at 31 March 2020. The Board has closed its operations in Bengaluru in financial year 2018-19. This was
done with intention streamlining costs and revenue. Further, the company continues its operations in Tirupur from leasehold
premises. However, in an effort to streamline further, the lease was surrendered, and subsequent new lease was taken. The
Company is streamlining its manufacturing process and is also exploring all possibilities for market expansion and eventually
generating profit. Considering all the efforts undertaken and further efforts in the pipeline, the management is hopeful of the
recoverability of the losses and earning profits in the coming years. However, this wild lepend entirely upon the condition of the
markets in which the Company has its core business, which have been severely impacted by the pandemic. Accordingly, the
